The site provides recipes for several dishes, and it allows a user to add and alter recipes, record the number of recipes used, and note other cooking-related information.

Evaluation Methods Used:

The Recipe Dashboard was evaluated using Chrome v. 80.0.3987.149 on a Windows 10 desktop computer. Assistive technologies used in this evaluation included NVDA (screen reader) and the Windows screen magnification function as well as exclusive use of the keyboard to navigate and operate the site content and functionality.
